It is intended as an enhancement to traditional asset allocations through the lowering of portfolio volatility and other downside risk metrics while maintaining an acceptable overall portfolio return.

Managers are reviewed quarterly and the portfolio will rebalance annually. All strategies are available as a prospectus-based mutual fund or ETF with daily liquidity.

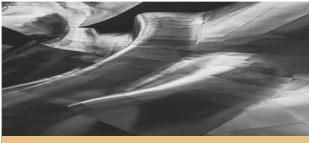

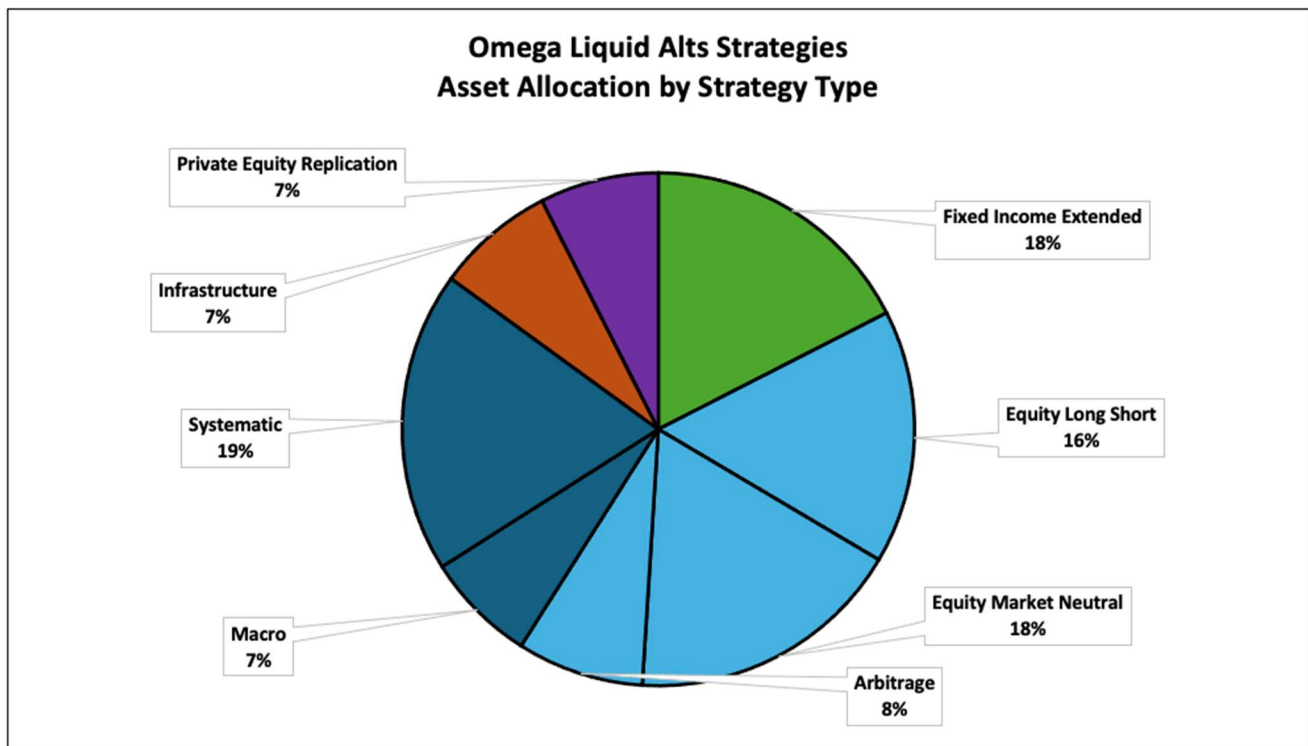
